Whereas the Administrator, Union Territory, Chandigarh, exercising the powers under Section 20 of the Indian Forest Act, 1927, had declared the area specified in the Schedule to the Chandigarh Administration, Home Department (Forest & Wildlife) notification bearing No. 18/11/24-HII(4)-92/3440, dated February 17, 1998 to be a reserved forest;

And whereas the Administrator, Union Territory, Chandigarh, is of the opinion that out of the aforesaid area of the reserve forest, the area mentioned in the Schedule below is an area of adequate ecological, faunal, <sup>(floral)</sup> geomorphological, natural and Zoological significance for the purpose of protecting, propagating and developing wildlife and its environment, which needs to be declared as a Sanctuary.

Now, therefore, the Administrator, Union Territory, Chandigarh, exercising the powers under clause (b) of Sub Section (1) of Section 26-A, of the Wildlife (Protection) Act, 1972, hereby specifies the area mentioned therein the Schedule to be a Sanctuary w.e.f. 17.03.1998.
